Prior to working in bowling, Mandy was a development director for the American Heart Association where she coordinated the Oklahoma City American Heart Walk. She has also worked in outside sales and purchasing for a regional plastics distribution warehouse. Mandy earned her degree in Political Science from the University of Oklahoma where she met her husband, Doug. Mandy and Doug have 3 daughers, Charlotte (11) and twins, Lainie (9) and Natalie (9). They live on a small ranch in Purcell, Oklahoma and love coming home to the country life. Mandy is active in the Norman community, serving on the Chamber of Commerce, as president of Visit Norman and as troop leader for her daughters' Girl Scouts troop. She serves on the BPAA Board of Directors, as current chair of the Education committee, a member of the Governance Committee and was past cChair of the Social Media Committee. She presently serves on the BPAA Membership Committee and on the IBC Youth Committee. Locally she served as president of her local Chamber of Commerce and on the board of directors of the rotary. She has been an active, sanctioned bowler for over 30 years. Chrissie is also a founding member of the Blessings in a Backpack program in her community that feeds 200 children each week. She is a proprietor who takes pride in creating a fun, viable atmosphere for both sport bowlers and recreational bowlers. Chrissie's sister is Leslie Bohn, wife of Parker Bohn, III, and her husband is pro bowler, Doug Kent. Chrissie resides in Newark with her husband and two children.

Tim Voss Columbus, Ohio



In 2003 Tim Voss left the comfort of a 25-year career in the corporate world to become an entrepreneur/bowling proprietor, buying Sequoia Pro Bowl, a 32-lane center in Columbus, Ohio. Tim has fought hard to maintain a strong league bowling focus with a full house of 32 lanes of leagues 7 days per week that included 1,217 adult USBC members last season. Tim has built a model youth program that has grown to 140 USBC youth bowlers and 20 USBC Certified Coaches this season. His center's youth activities include five high school teams and a Friday middle school "After School Bowling Club" started 2 years ago that sells out its bus capacity of 84 participants. He has been handson in rebuilding this early 60's vintage business and is proud to say he has used his education from BPAA conventions to capitalize on the entertainment business potential of bowling. He has used that to develop the center into a home for over 25 fundraisers, including the Don Johnson Memorial that has raised over \$150,000 for Children's Hospital and the Spielman Fund Bowl for a Cure that has exceeded \$100,000. Tim has found success in developing a strong summer business with an innovative "Prize-a-Palooza" program that fuels over 400 league bowlers, and by working with a bowling friend to create the Tony Black Open Doubles tournament that had 1,384 participants in a 4 weekend event last summer. Tim's 25 years of corporate marketing experience include Spalding and Rawlings Sporting Goods plus extensive work with iconic brands like the NBA, MLB, Harley Davidson and Disney. Tim and his co-owner wife Liz Kellough are residents of Powell, OH.

## Randy Thompson | Des Moines, Iowa

Randy Thompson is entering his final year as BPAA President after serving two years as Vice President/President-elect and two years as Secretary. He also represents BPAA on the USBC Board of Directors.

Randy is a second generation proprietor and has been in bowling management and ownership for nearly 40 years. He has served terms as local and state association Treasurer, Secretary and President. Jim Decker has served as Vice President for ther past year and prior to that as BPAA Secretary for two years. He served as the Pacific Coast Regional Director on the BPAA Board of Directors (2013-2016). He is a second generation proprietor with over 40 years' experience in the bowling industry and is owner/operator of Double Decker Lanes, a 50-lane center in Rohnert Park, California—the first bowling center in the nation to use a photovoltaic system (solar panels) for its main source of electric power.

On the national level Jim is the current International Bowl Expo Chairman and has served as Chairman of the Marketing Committee and as a member of the BPAA Beverage Committee. At the state level he has been on the Northern California Bowling Center's Board of Directors since 1995 serving two terms as President and currently is the chairman of the Pacific Coast Bowling Convention. He served on the California State USBC board and the local board as well. Jim received the Northern California Bowling Centers President's Award in 2001, 2006 and 2013; the California Bowling Proprietor of the Year award in 2007 from the California State USBC and Nor Cal BPA in 2010; the California Legislature 6th Assembly District "Green Entrepreneur of the Year" award in 2005 and the Al Malatesta award for contributions to the West Coast Bowling Convention in 2009

**Treasurer** 

Brian Borowski has been in the bowling business for over 35 years. He started his career working for an independent bowling center during high school and college. After earning his BS degree from the State University of New York at Buffalo (UB) in Business Management with concentrations in Finance and Management Information Systems, Brian began working with Brunswick Recreation Centers as an Assistant Manager and then as a GM. After three years he was promoted as an Internal Auditor and was responsible for auditing the P&Ls and implementing cost controls within the 120 bowling centers around the U.S. and Canada. In 1994 Brian purchased his first center in Des Moines, lowa, and during that time served as President of the Des Moines Proprietors' Association. In 1998 he sold his center in Iowa and purchased Sunset Bowl in Pueblo, Colorado, and then in 2000 purchased Ideal Lanes in Canon City, Colorado. He subsequently sold Ideal Lanes in 2006, Sunset Bowl in 2007 and in 2008 purchased two centers in western New York: Classic Lanes and Allie Brandt Lanes.

Brian has been very active at the local, state and national levels.
